KNOW ALL MEN BY THESE PRESENTS that Willie Trent and Mrs. Elizabeth M. Trent, his wife,

Grantor s, in consideration of One Dollar (\$1.00), receipt whereof is acknowledged, grant to Virginia Electric and Power Company, a Virginia corporation, its successors and assigns, hereinafter called Company, the right to construct, operate and maintain a pole line, at a location to be designated by Company, with all desirable appurtenances for the transmission and distribution of electricity and sound, including the wires and attachments of any other company, over, upon, and across the property of Grantor s situated in said county and state, described as follows:

A tract of land containing 51.3 acres, more or less, located on the North side of State Highway Route No. 630 about 6 1/2 miles East of Farmville in Farmville Magisterial District of Prince Edward County, Virginia, and adjoining the lands now or formerly owned by Monroe Foster and Taylor Eanes and Cora West.

It is agreed that said pole line and appurtenances erected hereunder shall be and remain the property of Company and that Company shall at all times have full and free ingress to and egress from and over the said property in order to construct and efficiently maintain and operate said line and appurtenances, with the right to make such changes, additions and alterations therein as Company may from time to time deem advisable; with the further right to trim, cut and keep clear all trees, limbs and undergrowth and other obstructions along said line or adjacent thereto that may in any way endanger or interfere with the proper and efficient operation of the same.
