which is hereby acknowledged, the said OWNERS do hereby grant, bargain, sell and convey to the TOWN, its successors and assigns a perpetual easement and right-of-way upon which to erect poles, towers and other supports, to guy, brace, re-locate and maintain the same, and to string, stretch, suspend and construct thereon wires, cables and other fixtures and appliances, including telephone wires, necessary or convenient for for the transmission and distribution of electric current and the right to transmit electric current thereon across and over a certain tract of land belonging to said OWNER, located in Farmville Mag., District, Prince Edward County, Virginia, adjoining the lands of W. H. Norris, India Dunnington & als, and containing approximately acres; together with the right of ingress and egress to and from said right-of-way, the right to keep said right-of-way free from structures of all kinds that may be . likely to interfere with the town's use thereof, and the right to cut and trim, and to keep trimmed, from the lands of the OUNER such limbs, underbrush, trees and other growth as may interfere with, or be likely to interfere with the foregoing uses. ## Tract No. 1

BEGINNING at a point on the southeast edge of the right-of-way of the state highway (U. S. Route 15) thence approximately S 20° E. (magnetic) 75 ft., more or less, to a point on the property line between owner and Mrs. W. G. Dunnington said property line being at the edge of the old abandoned highway, and said point being approximately 1360 ft. southwest of a corner between Mrs. W. G. Dunnington and Dr. Smith and Jas. Putney.

## Tract No. 2

BECINIVING at a point on the northwest edge of the right of way of state highway (U. S. Highway Route 15) approximately 0.45 Mi. southwest of a corner with W. H.Norris, thence approximately N 10° W. (magnetic) 1230 ft., more or less.
