

ARTICLES OF INCORPORATION

THE CARRIAGE HOMES AT LAKEWATCH PLANTATION PROPERTY OWNERS ASSOCIATION, INC.

The undersigned hereby associate to form a nonstock corporation under the provisions of Chapter 9, Title 13.1 of the Code of Virginia, 1950, as amended, and to that end set forth the following:

- 1. NAME: The name of the corporation is to be THE CARRIAGE HOMES AT LAKEWATCH PLANTATION PROPERTY OWNERS ASSOCIATION, INC. (hereinafter sometimes referred to as the "Corporation" or the "Association").
- 2. <u>MEMBERS</u>: The Corporation shall have members. The Corporation may have one or more classes of members as may be provided for in the bylaws. There shall not be issued or required any certificate evidencing membership.
- 3. <u>VOTING POWERS</u>: Members shall have voting rights and such other rights as may be provided in the bylaws.
- 4. REGISTERED OFFICE AND REGISTERED AGENT: The address of the initial registered office is 6720 Thirlane Road, N.W., Roanoke, Virginia 24019, which is in Roanoke County, Virginia. The name and address of the initial registered agent at the above address are: Edward C. Park, III, (registered agent); address: 6720 Thirlane Road, N.W., Roanoke, Virginia, 24019. Edward C. Park, III, is a resident of the Commonwealth of Virginia and a director of the corporation.

- 5. QUALIFICATION OF DIRECTORS: The bylaws may prescribe qualifications for a directorship. The bylaws may fix the number of directors or provide for a variable range (minimum and maximum number) of directors. The Developer shall be and constitute the initial Board (of Directors) and shall appoint the first subsequent Board of Directors. Thereafter, the directors shall be elected at the annual membership meeting and at every annual meeting thereafter. If the bylaws should provide for more than one class of membership, the bylaws may also authorize the election of a specified number of directors for one or more authorized class. Any director may be removed with or without cause. Vacancy on the Board of Directors shall be filled by majority vote of the Board. Each director shall be entitled to one vote unless otherwise provided by the bylaws.
- 6. <u>COMMITTEES</u>: The Board of Directors may create a committee and appoint members of the Board and serve thereon. Each committee shall have a minimum of two (2) members who shall serve at the pleasure of the Board. Committees shall have the authority as allowed by the Virginia Code or so limited and provided by the Board of Directors.
- 7. OFFICERS: The corporation shall have such officers with such titles and duties as shall be stated in the bylaws or in a resolution of the Board that is consistent with the bylaws. The Board may remove any officer, at any time, with or

without cause.

- 8. <u>POWERS AND DUTIES</u>: The Association may act and perform any lawful purpose. Nevertheless, the following shall be the specific duties and responsibility of the Association:
- (a) Maintain and mow the grass and maintain and provide or replace, as needed, landscaping on each lot; and
- (b) Maintain the driveway and the front walkway serving each lot and to provide for snow removal of the front walkway and driveway; and
- (c) Maintain any retaining wall(s) located on the lots and/or the property; and
- (d) Maintain and operate, in conjunction with any other Associations having the use and enjoyment of the same, the Park Area; and
- Maintain and care for the exterior of each residence (including the roof but excluding exterior lighting bulbs and glass), and improvements made thereon (excepting independent improvements made by an owner to the exterior of residence or lot which shall be the upon the responsibility of the owner of such lot), the yard, landscaping and driveway, subject to such rules, regulations, schedules and standards as may be set, imposed or regulated by the Developer, the Association or its Board of Directors; and
- (f) To maintain and care for the low impact development techniques implemented or required by the Developer.

- (g) Have the authority to perform any lawful act found and deemed necessary to effect its duties, obligations and responsibilities and determined for the benefit of this community; and
- (h) Utilize professional management, if desired, and/or hire such individuals and companies as needed to perform and/or otherwise satisfy these obligations.
- 9. <u>INDEMNIFICATION</u>: Indemnification of directors, officers, employees and agents of the corporation shall be as provided by Virginia Code, as amended.
- this Association is a "community association" as is defined in Section 13.1-814.1 of the Code of Virginia and will own or have under its care, custody or control real estate which is subject to a recorded declaration of covenants that obligate an owner by virtue or lot ownership of specific real estate to be a member of the corporation.
- 11. <u>DIRECTORS</u>: One individual shall constitute the initial Board of Directors of the corporation. The name and address of the individual who is to serve as the initial director is as follows:
