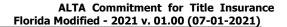

### **SCHEDULE B, PART II—Exceptions**

### 1. DEFINITIONS

- a. 
