KNOW ALL MEN BY THESE PRESENTS, Grantor in consideration of the sum of Ten Dollars (\$10.00) cash in hand paid by Grantee, the receipt whereof is hereby acknowledged, Grantor hereby grants unto the Grantee, its successors and assigns, a perpetual right of way that follows an existing roadway as set forth on Exhibit A hereto that is approximately twenty feet (20) in width and intersects with Pluto Road to be used solely for the right of ingress and egress to Grantee's adjacent property (approximately one (1) acre located in Richmond District, Raleigh County, West Virginia and identified as Tax Map Parcel ID 7-8-26), together with all rights and privileges incident to the use and enjoyment thereof and the right to clear and keep clear all brush along the right-of-way which might impair Grantee's right of ingress and egress, over and upon a portion of that certain tract situated in Raleigh County, West Virginia, designated as Raleigh County Tax Map ID: 7-22-21; being a tract of land containing 32.66 acre(s), more or less, and being described in Deed Book 5003 Page 9532, in the Raleigh County, West Virginia land records of the state aforesaid.





Exhibit A to Right of Way Agreement by and between Wilcox Industries, Inc. and Thomas K. Link Right of Way Location
